Requests for Quotations (RFQ)

1. This RFQ is for the Procurement of Non- Consulting Services for **Hiring of Firm for Pilot Android Based Survey for Issuance of Green Property Certificates in Punjab**.
2. The main objective of this assignment is to undertake a landmark land reform initiative through the launch of the Green Property Certificate, aimed at establishing a transparent, accurate, and fully digitized system of land records across the province.
3. The Islamic Republic of Pakistan has received financing from the World Bank (the Bank) towards the cost of the Punjab Urban Land Systems Enhancement (PULSE) project and intends to apply part of the proceeds toward payments under the contracts for **Hiring of Firm for Pilot Android Based Survey for Issuance of Green Property Certificates in Punjab**
4. Project Management Unit (PMU), Board of Revenue (BOR), Govt. of Punjab now invites quotations from Service Providers for the Services described in **Annex 1: Employer's Requirements**, attached to this RFQ.

Fraud and Corruption

5. The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in the attachment to the Contract Conditions (**Attachment A**).
6. In further pursuance of this policy, Service Providers shall permit and shall cause their agents (where declared or not), subcontractors, subconsultants, service providers, suppliers, and personnel, to permit the Bank to inspect all accounts, records and other documents relating to the RFQ and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

Eligible Services

7. All the Services i-e **Hiring of Firm for Pilot Android Based Survey for Issuance of Green Property Certificates in Punjab** to be supplied under the Contract and financed by the Bank may have their origin in any country in accordance with Para. 10.

Eligible Service Providers

8. Joint venture (JV) is not allowed.
9. A Service Provider may have the nationality of any country, subject to the restrictions pursuant to para. 9 and 10 hereinafter. A Service Provider shall be deemed to have the

nationality of a country if the Service Provider is constituted, incorporated or registered in, and operates in conformity with, the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the determination of the nationality of proposed subcontractors or subconsultants for any part of the Contract.

10. Firms and individuals may be ineligible if so indicated in para. 10 below and:
 - (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of Goods or the contracting of Works or Services required; or
 - (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of Goods or contracting of Works or Services from that country, or any payments to any country, person, or entity in that country.
11. In reference to paras. 6 and 8, for the information of Service Providers, at the present time firms, goods and services from the following countries are excluded from this procurement process:
 - (a) Under para. 6 and 9 (a): *none*
 - (b) Under para. 6 and 9 (b): *none*
12. A Service Provider that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines, in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in the attachment to the Contract Conditions (**Attachment A**) **paragraph 2.2 d.**, shall be ineligible to submit Quotations or be awarded or otherwise benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. A list of debarred firms and individuals is available on the Bank's external website: <http://www.worldbank.org/debarr>.
13. Service Providers that are state-owned enterprises or institutions in the Employer's country may be eligible to compete and be awarded a Contract(s) only if they can establish, in a manner acceptable to the Bank, that they:
 - (a) are legally and financially autonomous;
 - (b) operate under commercial law; and
 - (c) are not under supervision of the Employer.
14. A Service Provider shall not have a conflict of interest. Any Service Provider found to have a conflict of interest shall be disqualified. A Service Provider may be considered to have a conflict of interest for the purpose of this Requests for Quotations process, if the Service Provider:
 - (a) directly or indirectly controls, is controlled by or is under common control with another Service Provider that submitted a Quotation; or

- (b) receives or has received any direct or indirect subsidy from another Service Provider that submitted a Quotation; or
- (c) has the same legal representative as another Service Provider that submitted a Quotation;
- (d) has a relationship with another Service Provider that submitted a Quotation, directly or through common third parties, that puts it in a position to influence the Quotation of another Service Provider, or influence the decisions of the Employer regarding this Requests for Quotations process; or
- (e) or any of its affiliates participated as a consultant in the preparation of the scope the Services, that are the subject of the Requests for Quotations process; or
- (f) or any of its affiliates has been hired (or is proposed to be hired) by the Employer or Borrower for implementing the Contract; or
- (g) would be providing Goods, works, or non-consulting services resulting from, or directly related to consulting services for the preparation or implementation of the project specified in this Requests for Quotations, that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or
- (h) has a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who:
 - (i) are directly or indirectly involved in the preparation of the Requests for Quotations or specifications and/or the evaluation of Quotations, of the subject Contract; or (ii) would be involved in the implementation or supervision of such Contract unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the Requests for Quotations process and execution of the Contract.

Performance Security

15. The successful Service Provider shall submit a **Performance Security** in accordance with the Contract Conditions.

Validity of offers

16. The offers shall be valid for the period of **60 days** from the submission date as specified in paragraph 20.

Quoted Price

17. Prices shall be quoted in the following manner:

- (i) the price of the Services quoted shall include sales tax and all other applicable taxes already paid or payable on the Services if the Contract is awarded to the Service Provider; and
- (ii) the price for inland transportation, insurance, and other local services required to convey the Service Personnel to their final destination.
- (iii) The price for related services.

18. The Service Provider shall quote all the prices in **Pak Rupees**.

19. Submission of Quotations

20. Quotations are to be submitted in the form attached at **Annex 2 and in one hardcopy**.

Opening of Quotations

23. Quotations will be opened by the Employer's representatives immediately after the deadline for the submission of Quotations.

Evaluation of Quotations

24. Quotations will be evaluated to ensure compliance with the Technical Specifications, Delivery and Completion Schedules and any other requirements of the RFQ.
25. Evaluation of the Technical Proposal will include an assessment of the Service Provider's technical capacity to mobilize key equipment and personnel for the contract consistent with its proposal regarding work methods, scheduling, and material sourcing in sufficient detail and fully in accordance with the requirements stipulated in **ANNEX-1, Employer's Requirements**.
26. The comparison shall be on the basis of final prices (inclusive of all the applicable taxes) plus cost of inland transportation and insurance to place of destination, for Services provided from within the Borrower's country; together with prices for any required installation of equipment, training, commissioning and other services at project site. The evaluation of prices shall not take into account custom duties and other taxes levied on imported goods/services quoted CIP and sales and similar taxes levied in connection with the sale or delivery of goods/services.
26. The lowest evaluated price will be determined after correcting any arithmetic errors and other specified adjustments, if any.
28. Quotations will be evaluated for the whole lot/package under this RFQ. If a Price Schedule shows items listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the Price Schedule shall be assumed not included in the Quotation, and provided that the Quotation is substantially responsive, the highest of

the item price as quoted by substantially responsive Service Providers will be added to the Quoted Price and the equivalent total price of the Quotation so determined will be used for price comparison.

29. For evaluation and comparison purposes, the currency of the Quotations shall be a single currency, Pak Rupees.

Contract Award

30. The Contract will be awarded to the Service Provider/s who meets the following criteria:

- a. is eligible and offers eligible Services;
- b. offers the lowest evaluated price/s to the Employer;
- c. technically compliant quotation;
- d. guarantees delivery, in accordance with the delivery period/s;
- e. is registered with FBR as an active taxpayer for the last **five (05) years** and at the time of quotation submission, provides the following documents:
 - i. verifiable and valid active GST and NTN certificate.
- f. provides copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the quotation to commit the Service Provider;
- g. **Firm Experience and Mandatory Qualification Criteria**
 - At least five (05) years of experience in field of conducting large scale civil survey with DGPS/GNSS/Total station and survey data processing at national, provincial or regional level preferably. The firm should be able to demonstrate experience of organizing large scale surveys. etc. in the private/public sector, registered firms with relevant regulatory authorities.

Firm must demonstrate a proven track record of successfully completed at least **two (02)** or more similar contract(s)/ service agreement(s) related to services of a similar nature in the above fields. (individual contract value **PKR 80 million** or above) (**Annex-A**) (Contract Agreement along with successful completion certificates must be attached);

- The minimum required annual volume of services for the successful Bidder **in any of last five (05) years** shall be: **60 million**.
- The minimum quantifiable amount of liquid assets of the successful Bidder shall be: **40 million**.
- h. **Key Personnel:** The firm shall propose a qualified and experienced multidisciplinary team with clearly defined roles and responsibilities. The proposed team shall include, but not be limited to, the following positions: The survey Firm shall provide their staff deployment plan in their Bid. Preference should be given to hiring of experienced professionals who have sufficient

experience in conducting android based surveys at district level across Punjab. The basic GIS knowledge background and off-line map reading will be an added advantage keeping in view of the nature of the assignment.

- l. affidavit regarding non-involvement in any arbitration/ litigation with any government agency / department/Autonomous body/private sector/ organization and not blacklisted anywhere in Pakistan (only for local Service Providers) on a 200 Rs stamp paper must be attached.

31. Subcontractors' experience and resources will not be taken into account in determining the Service Provider's compliance with the qualifying criteria, unless otherwise stated in the Qualification Requirements above.

32. The Employer shall invite by the quickest means [*e-mail*] the successful Service Provider/s for any discussion/ negotiation that may be needed to conclude the contract or otherwise for contract signature.
33. The Employer shall communicate by the quickest means with the other Service Providers on its contract award decision. An unsuccessful service provider may request clarifications as to why its quotation was not determined to be successful. The Employer will address this request within a reasonable time.
34. The Employer shall publish a contract award notice on its website with free access, if available, or in a newspaper of national circulation or UNDB online, within 15 days after award of contract. The information shall include the name of the successful Service Provider/s, the Contract Price, the Contract duration, summary of its scope and the names of the Service Provider/s and their quoted and evaluated prices.

Appendix-A

Description of Services

Performance Specifications and Drawings

1. BACKGROUND

The Punjab Urban Land Systems Enhancement (PULSE) project aims to digitize land records and create a unified, spatially grounded cadastral map of Punjab. To measure the land parcel as per the possession, PULSE is introducing a verification mechanism leading to the issuance of a "Green Property Certificate." This certificate confirms that a land parcel's digital record matches the ground reality.

PULSE intends to hire a qualified Survey Firm to provide **On-Demand** field survey services using **high-precision survey equipment** (e.g., DGPS, total station, GNSS/IMU, or other approved technologies) to verify land parcel details upon receiving specific applications from landholders.

2. OBJECTIVES OF THE ASSIGNMENT

The core objective of the firm, including but not limited to, is to conduct ground truthing and verification of specific cadastral land parcels. The survey team must verify the following key parameters on the ground to enable PULSE to issue the Green Property Certificate:

1. **Person Identification:** Verify the identity of the person present on the land against the applicant's details (CNIC/Biometric verification).
2. **Verification of Possession:** Confirm physically that the applicant is in actual possession of the land.
3. **Verification of Land Parcel Area:** Measure the area on the ground using DGPS to verify if it matches the area mentioned in the ownership documents.
4. **Verification of Shape/Geometry:** Re-validate that the shape of the plot on the ground matches the digitized vector shape drawn in the PULSE cadastral map, if required.
5. **Local Witness Confirmation:** Confirm by the local witness for the provided information and its biometric verification.
6. **Digital Submission via Android App:** Ensure that all spatial data, attribute data, and digital evidence are captured and submitted in real-time through the designated survey application using the secure login credentials provided to the survey team.
7. **Future Extensions & Flexibility:** The Survey Firm shall accommodate additional verification parameters, data fields, or functional modules as may be defined by PULSE in the future. The firm shall implement such extensions within the existing survey process or survey application framework, ensuring compatibility and continuity with previously collected data and workflows.

3. SCOPE OF SERVICES

The selected Survey Firm shall perform the following activities:

- **Mobilization on Demand:** The firm must maintain a presence in the assigned district. Upon notification from the PULSE District Office regarding a landholder's application, the firm must mobilize a survey team to the specific site within a defined timeframe (e.g., 24-48 hours).
- **Geo-Spatial Data Collection:** Conduct a high-precision survey using DGPS (RTK/PPK mode) to capture the boundary coordinates of the parcel with centimeter-level accuracy.
- **Attribute Data Collection:** Collect associated attribute information, including site photographs and on-site verification of the occupant and witnesses using survey application.
- **Data Submission:** Process the raw DGPS data by drawing parcel boundaries in the survey application, and submit the finalized geospatial and attribute data along with the Field Verification Report and DGPS raw files (e.g., Shapefiles, RINEX or any other client-approved formats) to the PULSE District Office.

4. OPERATIONAL WORKFLOW & QUALITY ASSURANCE

1. **Assignment of Task:** The PULSE will forward the application details/coordinates to the Survey Firm.
2. **Field Survey:** The Firm conducts the survey and measures the parcel area and boundaries.
3. **Submission:** The Firm submits the processed data to the DM.
4. **Validation:** The PULSE District Manager/Quality Assurance team will review the submitted data.
 - *Note:* The Client reserves the right to conduct random spot checks.
5. **Rectification:** If the data is found to be erroneous, incomplete, or inaccurate, the Survey Firm shall be liable to **re-survey the specific parcel at their own cost**. Payment will only be processed after the data is accepted by the Client.

PRICING STRUCTURE:

Bidders are required to submit a comprehensive unit rate per land parcel. The quoted rate must be all-inclusive, covering all costs related to mobilization, office maintenance in the district, equipment (DGPS), human resources, fuel, data processing, and submission via the Android application. No separate charges for mobilization or overheads will be entertained.

Attachment A to the Conditions of Contract

Fraud and Corruption

(Text in this Appendix shall not be modified)

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and Service Providers; any sub-contractors, sub-consultants, service providers or Service Providers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

- a. Defines, for the purposes of this provision, the terms set forth below as follows:
 - i. “corrupt practice” is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
 - ii. “fraudulent practice” is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii. “collusive practice” is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
 - iv. “coercive practice” is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - v. “obstructive practice” is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank’s inspection and audit rights provided for under paragraph 2.2 e. below.

- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, Service Providers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring misprocurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner;¹ (ii) to be a nominated² sub-contractor, consultant, manufacturer or Service Provider, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;
- e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and Service Providers, and their sub-contractors, sub-consultants, service providers, Service Providers, agents personnel, permit the Bank to inspect³ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

¹ For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

² A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its pre-qualification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

³ Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
