The Project Management Unit-Board of Revenue has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement Project and intends to apply part of the proceeds toward payments under the contract for Digitalization of land records maintained by non-BoR authorities.

Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) Single Stage-One Envelop as specified in the World Bank's "Procurement Regulations for IPF Borrowers -" November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information from Project Management Unit-Board of Revenue, Procurement Specialist (pspmupulse@punjab-zameen.gov.pk) and inspect the bidding document during office hours *i.e.* **0900 to 1700 hours** at the address given below.

The bidding document in ENGLISH may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of PKR 1,000 (Rupees One Thousand Only) in the Treasury/State Bank of Pakistan under Head of Account "C03870-Others".
6. Bids must be delivered to the address below on or **before 11.00 a.m. July 25,2023**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **July 25,2023** immediately after the bid submission.
7. A pre-bid meeting will be held on **06 July, 2023 at 11:00 am** at the address given below.
8. All Bids must be accompanied by a Bid Security of PKR 3,600,000/-
