bid tu 1. yest)	What is the benchmark of Geodetic Control Network?	Level – 1 Monuments will be installed at approximately 25km apart from each other while Level – 2 Monuments will be installed at approximately 10km apart from each other for Geodetic Control Network.

2.	Who will identify the sites / locations?	As mentioned in the "Appendix A – Description of Service" of Bidding document, the Client will provide the list of sites / locations initially, the Contractor will visit those sites / locations to check the feasibility in light of the SOPs of Survey of Pakistan. After finalization of sites / locations by Contractor, the Client will get the approval of those sites / location from the relevant authorities. The selected sites will be Govt. Structure Buildings.
3.	How to monitor the field work?	Referring to the "Appendix A – Description of Service", the Contractor will prepare a dashboard for monitoring daily progress and android application for field work i.e. uploading of picture of final selected site and picture of each stage of construction process along with details of each monument.
4.	Is reading included in the scope of work of this activity?	Referring to the "Appendix A – Description of Service", the Contractor will only establish / install the monuments at selected sites / location as per the specifications mentioned in the RFB document. However, GNSS reading is not included in the scope of this activity.
5.		No, new monuments will be established / installed at each approved site / location.
6.	What is the Total No. of Monuments to be established in Punjab?	Referring to the "Appendix A – Description of Service" the estimated quantities as per the given installation distance/SOP is mentioned below: 1 st Order Benchmarks = 134 2 nd Order Benchmarks = 1801 So, the Activity Schedule of Section IV of Bidding Document will be filled with above mentioned quantities for quoting total bid price.
7.	Please clarify the required qualifications for the proposed team.	Referring to the clause 2.2 c (Key Personnel) of Section III Evaluation and Qualification Criteria of Bidding document, it was clarified that the mentioned degrees with commas (,) are equivalent so proposed
