The Government of Punjab has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement Project (PULSE), and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") shall develop a Security Management Plan (SMP) for the whole province Punjab (the project area). This will increase the project's capacity to mitigate and manage risks for the project. This work will be undertaken in conformance with the security-related aspects of World Bank Good Practice Note Assessing and Managing the Risks and Impacts of the use of Security Personnel under Environment and Social Framework.

The Project Management Unit (PMU), Board of Revenue now invites eligible consulting firms/NGOs ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Key Experts will not be evaluated at the expression of interest stage. The prospective consultant(s) shall have the following experience:

i. The consulting firm must have proven knowledge and five (5) years of experience in managing consultancies.

ii. Preference will be given to those firms which have conducted and developed SMPs of International Financing Agencies funded projects at provincial and national level.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. The Consultant shall clearly describe the anticipated role of each JV partner as well as Sub Consultant within the association. In the case of joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract whereas each partner within the JV shall meet the qualification and experience requirement for the assigned role, if selected.

A Consultant will be selected in accordance with the Consultant's Qualifications-based Selection (CQS) method set out in the Procurement Regulations.
