The Project Management Unit-Board of Revenue has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement (PULSE) Project and intends to apply part of the proceeds toward payments under the contract for Procurement of Android-Based Survey for Precise Cadastral Mapping of Eight (08) Districts (Lahore, Layyah, Khushab, Khanewal, Sahiwal, Nankana Sahib, Toba Tek Singh, Sialkot) in Punjab under PULSE Project.

2. The Project Management Unit-Board of Revenue now invites sealed Bids from eligible Bidders for Android-Based Survey for Precise Cadastral Mapping of Eight (08) Districts (Lahore, Layyah, Khushab, Khanewal, Sahiwal, Nankana Sahib, Toba Tek Singh, Sialkot) in Punjab under PULSE Project.
3. Bidding will be conducted through **international competitive procurement** using a Request for Bids (RFB) -**Single Stage Two-Envelope** as specified in the World Bank’s “Procurement Regulations for IPF Borrowers -” November 2020 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. 5. The bidding document in ENGLISH may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a

nonrefundable fee of PKR 2,500/- or USD 100/- The method of payment for local bidder will be through submission of Challan Form in the Treasury/State Bank of Pakistan under Head of Account “C03870-Others”. (Challan Form is available <https://pulse.gop.pk> under Procurement Section.) and for international bidder through provision of Demand Draft/Pay Order of equivalent amount in USD in the name of **Project Director, PMU-BOR**.

6. Bids must be delivered to the address below **on or before 11.00 a.m. February 20,2024**. Electronic Bidding will not be permitted. Late Bids will be rejected. The outer Bid envelopes marked “**ORIGINAL BID**”, and the inner envelopes marked “**TECHNICAL PART**” will be publicly opened in the presence of the Bidders’ designated representatives and anyone who chooses to attend, at the address below on **February 20,2024** immediately after the bid submission. All envelopes marked “**FINANCIAL PART**” shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
