

Terms for Reference for Network System Engineer

1. Background

Punjab Urban Land Systems Enhancement (PULSE) is a strategic initiative aimed at strengthening land administration, revenue collection, and urban land management in Punjab. The Senior Revenue Officer will play a critical role in providing technical support and operational assistance to ensure the effective implementation of the project's land revenue components.

2. Objectives

- To support the development and implementation of land revenue policies and procedures.
- To enhance the capacity of land revenue departments and staff.
- To ensure smooth operational functioning of land revenue activities within PULSE.
- To assist in data collection, analysis, and reporting related to land revenue.

3. Scope of Work

The Senior Revenue Officer will be responsible for, but not limited to, the following:

- Provide expert guidance on land revenue policies, procedures, and best practices.
- Assist in streamlining land record management and revenue collection processes.
- Support the digitization and integration of land revenue data systems.
- Facilitate training and capacity-building sessions for departmental staff.
- Coordinate between various stakeholders including government departments, local authorities, and community groups.
- Oversee daily operational activities related to agriculture land partitioning.
- Monitor and evaluate the performance of Field Revenue Officers, reporting issues and recommending solutions.
- Support the implementation of Mass level partitioning drive and feedback collection through public map displays.
- Supervision of PULSE Revenue Field Staff.
- Technical assistance related to any revenue matter.

4. Qualifications and Experience

- Minimum 16 years of Education.
- Must have completed the Patwar Course.

- At least Twenty (20) years post Patwar course experience in Revenue Field/matters.
- Must have experience in revenue work, Land Consolidation, Land Settlement, and Revenue record management.

5. Duration and Location

- The position is initially for a period of one year, with possibility of extension based on performance and project needs.

6. Other Conditions

- The Senior Revenue Officer shall adhere to all applicable project policies, guidelines, and standards.
- Confidentiality and integrity are essential in handling land data and related information.
