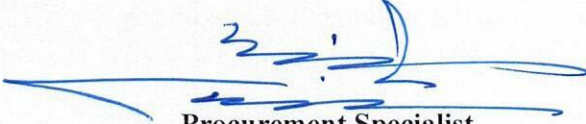

The Project Management Unit-Board of Revenue has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement Project and intends to apply part of the proceeds toward payments under the contract for Procurement of Preparation of Remaining Missing/Unavailable Massave Maps in All Divisions of Punjab Package-I, (Lot Wise) Bahawalpur, DG Khan & Sargodha Divisions under PULSE Project.

Bidding will be conducted through national competitive procurement using a Request for Bids (RFB) Single Stage-One Envelop as specified in the World Bank's "Procurement Regulations for IPF Borrowers -" November 2020 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

6. Bids must be delivered to the address below on or **before 11.00 A.M. October 30th, 2025**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **October 30th, 2025**, immediately after the bid submission.
