

The Project Implementation Unit, Punjab Urban Land Systems Enhancement (PULSE) Project, Govt. of Punjab has received financing from the World Bank toward the cost of the Punjab Urban Land Systems Enhancement (PULSE) Project, and intends to apply part of the proceeds toward payment of Hiring of Consulting Firm for Feasibility and Implementation of Map Projection for Punjab Province.

The objective of this consulting service is to conduct a feasibility study and develop appropriate projection/projections suitable for most precise and accurate measurements for cadastral mapping. The consulting firm need to address the limitations and challenges associated with the current coordinate system UTM Zone-42 & 43 projection system for Punjab Urban Land Systems Enhancement Project.

The PIU, PULSE now invites eligible consulting firms to indicate their interest in providing the required services as explained in the ToR. Interested firms should provide the following information demonstrating that they have the required qualifications and relevant experience to perform this assignment. Key Experts will not be evaluated at the shortlisting stage. The parameters for evaluating EOI responses are given below: -

- (i) Valid/active NTN and GST Number with Income Tax return from 2022 to 2023
- (ii) In case, collection of any spatial data from field to carry out this assignment, the firm will hire services of SOP registered firm/company.
- (iii) Verifiable experience (study or Implementation of coordinate projection systems in different geospatial measurement projects or similar geodesy-related projects) in Pakistan or other countries.
- (iv) At least five (05) years verifiable experience in geospatial and geodesy domains.

Note: The firm must provide the documentary evidence of the assignments carried out.



The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a subconsultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected. Firms interested to participate in JV should submit information for each partner, which will be assessed independently regardless of capacity/experience of the other partner. For firms in arrangement of lead sub-consultant, only the experience and capacity of lead firm will be assessed. However, such arrangements should be clearly mentioned in Expressions of Interest Response.

A Consultant will be selected in accordance with the <u>Consultant's Qualification-based</u> <u>Selection Method</u> set out in the Procurement Regulations.
