Request for Quotation (RFQ)

- 1. This RFQ is for Hiring of Services for the Entry of Mutations in the Revenue Record in Lahore.
- 2. The Islamic Republic of Pakistan has received financing from the World Bank (the Bank) toward the cost of the Punjab Urban Land Systems Enhancement (PULSE) project and intends to apply part of the proceeds toward payments under the contract for Hiring of Services for the Entry of Mutations in the Revenue Record in Lahore.
- 3. PULSE, Punjab Land Records Authority (PLRA), Govt. of Punjab now invites quotations from Service Providers for the Services described in Annex 1: Employer's Requirements, attached to this RFQ.

Fraud and Corruption

- 4. The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in the attachment to the Contract Conditions (Attachment A).
- 5. In further pursuance of this policy, Service Providers shall permit and shall cause their agents (where declared or not), subcontractors, subconsultants, service providers, suppliers, and personnel, to permit the Bank to inspect all accounts, records and other documents relating to the RFQ and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

Eligible Services

6. All the Services to be supplied under the Contract and financed by the Bank may have their origin in any country in accordance with Para. 10.

Eligible Service Providers

- 7. A joint venture (JV), is not eligible to participate in this procurement.
- 8. A Service Provider may have the nationality of any country, subject to the restrictions pursuant to para. 9 and 10 hereinafter. A Service Provider shall be deemed to have the nationality of a country if the Service Provider is constituted, incorporated or registered in, and operates in conformity with, the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the

determination of the nationality of proposed subcontractors or subconsultants for any part of the Contract.

- 9. Firms and individuals may be ineligible if so indicated in para. 10 below and:
 - (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of Goods or the contracting of Works or Services required; or
 - (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of Goods or contracting of Works or Services from that country, or any payments to any country, person, or entity in that country.
- 10. In reference to paras. 6 and 8, for the information of Service Providers, at the present time firms, goods and services from the following countries are excluded from this procurement process:
 - (a) Under para. 6 and 9 (a): none
 - (b) Under para. 6 and 9 (b): none
- 11. A Service Provider that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines, in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in the attachment to the Contract Conditions (Attachment A) paragraph 2.2 d., shall be ineligible to submit Quotations or be awarded or otherwise benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. A list of debarred firms and individuals is available on the Bank's external website: http://www.worldbank.org/debarr.
- 12. Service Providers that are state-owned enterprises or institutions in the Employer's country may be eligible to compete and be awarded a Contract(s) only if they can establish, in a manner acceptable to the Bank, that they:
 - (a) are legally and financially autonomous;
 - (b) operate under commercial law; and
 - (c) are not under supervision of the Employer.
- 13. A Service Provider shall not have a conflict of interest. Any Service Provider found to have a conflict of interest shall be disqualified. A Service Provider may be considered to have a conflict of interest for the purpose of this Request for Quotations process, if the Service Provider:
 - (a) directly or indirectly controls, is controlled by or is under common control with another Service Provider that submitted a Quotation; or
 - (b) receives or has received any direct or indirect subsidy from another Service Provider that submitted a Quotation; or
 - (c) has the same legal representative as another Service Provider that submitted a Ouotation;

- (d) has a relationship with another Service Provider that submitted a Quotation, directly or through common third parties, that puts it in a position to influence the Quotation of another Service Provider, or influence the decisions of the Employer regarding this Request for Quotations process; or
- (e) or any of its affiliates participated as a consultant in the preparation of the scope the Services, that are the subject of the Request for Quotations process; or
- (f) or any of its affiliates has been hired (or is proposed to be hired) by the Employer or Borrower for implementing the Contract; or
- (g) would be providing Goods, works, or non-consulting services resulting from, or directly related to consulting services for the preparation or implementation of the project specified in this Request for Quotations, that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or
- (h) has a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who: (i) are directly or indirectly involved in the preparation of the Request for Quotations or specifications and/or the evaluation of Quotations, of the subject Contract; or (ii) would be involved in the implementation or supervision of such Contract unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the Request for Quotations process and execution of the Contract.

Performance Security

14. The successful Service Provider shall submit a Performance Security in accordance with the Contract Conditions.

Validity of offers

15. The offer/Quotation shall be valid until 90 days from the last date of submission of quotations.

Quoted Price

- 16. Prices shall be quoted in the following manner:
 - the price of the Services quoted shall include sales tax and all other applicable taxes already paid or payable on the Services if the Contract is awarded to the Service Provider; and
 - (ii) the price for inland transportation, insurance, and other local services required to convey the Service Personnel to their final destination (Project Site).
- 17. The Service Provider must quote all the prices in Pak Rupees.

Clarifications

The Employer will forward copies of its response to all Service Providers including a description of the inquiry but without identifying its source.

Submission of Quotations

- 19. Quotations are to be submitted in the form attached at Annex 2 and in one hardcopy and one softcopy.
- 20. The deadline for submission of Quotations is January 05, 2026, till 11:00 a.m.

Opening of Quotations

22. Quotations will be opened by the Employer's representatives immediately after the deadline for the submission of Quotations.

Evaluation of Quotations

- 23. Quotations will be evaluated to ensure compliance with the Delivery and Completion Schedules and any other requirements of the RFQ.
- 24. Evaluation of the Technical Proposal will include an assessment of the Service Provider's technical capacity to mobilize key equipment and personnel for the contract consistent with its proposal regarding work methods, scheduling, and material sourcing in sufficient detail and fully in accordance with the requirements stipulated in Annex-A, Employer's Requirements.
- 25. The comparison shall be on the basis of final prices (inclusive of all the applicable taxes) plus cost of inland transportation and insurance to place of destination, for Services provided from within the Borrower's country; together with prices for any required installation of equipment, training, commissioning and other services. The evaluation of prices shall not take into account custom duties and other taxes levied on imported goods/services quoted CIP and sales and similar taxes levied in connection with the sale or delivery of goods/services.
- 26. The lowest evaluated price will be determined after correcting any arithmetic errors and other specified adjustments, if any.
- 28. Quotation will be evaluated for the whole package under this RFQ. If a Price Schedule shows items listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the Price Schedule shall be assumed not included in the Quotation, and provided that the Quotation is substantially responsive, the average of the item price as quoted by substantially responsive Service Providers will be added to the Quoted Price and the equivalent total price of the Quotation so determined will be used for price comparison.
- 29. For evaluation and comparison purposes, the currency of the Quotations shall be a single currency, Pak Rupees.

Contract Award

- 30. The Contract will be awarded to the Service Provider/s who meets the following criteria:
 - a. is eligible and offers eligible Services;
 - b. offers the lowest evaluated price/s;
 - c. technically compliant quotation;
 - d. The firm must be registered with FBR as an active taxpayer for the last three years i.e., 2022 2024 and at the time of bid submission, provides the following documents:
 - a. verifiable and valid GST and NTN certificate.
 - b. income tax returns for the year 2022 2024.
 - e. The must provide copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder;
 - f. The firm must have experience in Services of a similar nature for the last three years, and provides details of Services under way or contractually committed; and names and address of clients who may be contacted for further information on those contracts;
 - g. The firm must has performed Services during the last three years **two similar nature** large scale work accumulatively amounting to **PKR 20 million** (relevant valid and verifiable copies of Service Orders/ Contract Agreement along with successful competition certificates must be attached);
 - h. The firm must have Liquidate assets of last year of PKR. 10 million.
 - i. The firm will provide information regarding any litigation, current or during the last three years, in which the Bidder is involved, the parties concerned, and disputed amount.
 - j. affidavit regarding non-involvement in any arbitration/ litigation with any government agency / department/Autonomous body/private sector/ organization and not blacklisted anywhere in Pakistan (only for local bidders).
- 31. Subcontractors' experience and resources will not be taken into account in determining the Company's compliance with the qualifying criteria, unless otherwise stated in the Qualification Requirements above.
- 32. The Employer shall invite by the quickest means [e-mail] the successful Service Provider/s for any discussion/ negotiation that may be needed to conclude the contract or otherwise for contract signature.
- 33. The Employer shall communicate by the quickest means with the other Service Providers on its contract award decision. An unsuccessful service provider may request clarifications as to why its quotation was not determined to be successful. The Employer will address this request within a reasonable time.
- 34. The Employer shall publish a contract award notice on its website with free access, if available, or in a newspaper of national circulation or UNDB online, within 15 days after award of contract. The information shall include the name of the successful Service Provider/s, the Contract Price, the Contract duration, summary of its scope and the names of the Service Provider/s and their quoted and evaluated prices.

The firm will report to the Concerned OIC of the PULSE Project and ensure regular updates through progress reports and review meetings.

1.2 Scope of Services/Technical Specifications

SCOPE OF WORK

1. Background and Objectives

The Project Implementation Unit (PIU), PULSE intends to hire a non-consulting firm to modernize the land record maintenance process. The primary objective is to digitize the manual Mutation records to ensure accuracy, transparency, and accessibility. The firm shall be responsible for the Data entry, scanning, and indexing (if required) of mutation records. The Service provider will establish fully functional Data Entry Labs in Lahore.

2. Scope of Services

The Firm shall be required to execute the work in the designated place in Lahore (Central). The scope is divided into three key components:

- 1. Establishment of Data Entry Labs (Infrastructure Setup)
- 2. Data Entry of Mutation Records
- 3. Scanning and Indexing
- 4. Validation of the data entry records.

3. Detailed Responsibilities

3.1 Component A: Establishment of Data Entry Labs

The Firm is required to develop and operationalize one (01) central Data Entry Lab in Lahore. The lab must be equipped to support 100 Data Entry Operators (DEOs) simultaneously.

Key Requirements per Lab:

- **Premises & Renovation:** The Firm must secure/prepare a suitable space (unless provided by the Client) and ensure it is renovation-ready for high-volume IT operations.
- **Furniture & Fixtures:** Provide suitable chairs and desks for 100 operators, plus supervisory staff stations.

• IT Equipment:

- o **Computers:** Provision, install, and maintain **100 Computer Systems** (Minimum Core i5 or equivalent, 8GB RAM, SSD) for data entry operators.
- Printers: Provision of one (01) Large Heavy-Duty Printer capable of high-volume printing for reporting and verification purposes.
- o **Scanners:** Provision of adequate scanners (Minimum A3/A4 size, Overhead Book /ADF) to match the scanning volume speed required.

• Office Environment:

o **Air Conditioning:** Installation of sufficient Air Conditioning units to maintain an optimal temperature for equipment and staff.

- o **Power Backup:** Provision of UPS and/or Generators to ensure uninterrupted operations during power outages.
- **Stationery & Consumables:** Supply of all necessary office stationery (paper, toner, binding material, files, etc.) on a daily/monthly basis.

3.2 Component B: Data Entry

The Firm shall perform data entry of the scanned mutation records into the software/database provided or designated by the Client.

• Data Entry:

- o Entry of alphanumeric (Urdu/English) data from the scanned images into the system.
- o Fields to be entered typically include: Mutation No., Date, Type of Mutation, Seller/Buyer Names, CNICs, Area, and Revenue details.

• Quality Assurance (QA):

- o **Double Entry/Verification:** The Firm must implement a QA mechanism (e.g., double-blind entry or supervisor verification) to ensure **100% data accuracy**.
- o **Error Reporting:** Inconsistencies between the physical record and logical data (e.g., total share calculations) must be reported to the Revenue Administration for correction.

3.3 Component B: Scanning and Indexing

The Firm shall scan legacy mutation registers/records retrieved from the Revenue Record Rooms.

• Handling of Physical Records:

- o **Bound Registers:** The Firm is **strictly prohibited** from unbinding stitched registers (e.g., *Register Haqdaran Zamin*). Appropriate flatbed or overhead book scanners must be used.
- o **Loose Sheets:** Loose records (e.g., *Mutations, Fard Badar*) must be handled with care and returned to their specific folders/bundles immediately after scanning.

• Scanning Specifications:

- Scanning shall be performed at a minimum resolution of 200-300 DPI in color to ensure legibility.
- Scanned images must be saved in PDF/JPEG format (as per Client requirements) and linked to a unique identifier.
- o The Firm must ensure the integrity of the physical record during the scanning process (no unbinding of stitched registers unless authorized).

• Indexing:

- o Images must be indexed with metadata such as **District**, **Tehsil**, **Mauza**, **Year**, **Mutation Number**, and **Date**.
- o Indexing shall be done in Urdu/English as specified by the Client.

4. HR / Staffing Requirements

The Firm must deploy the following minimum staff in each lab to ensure timely completion:

- Data Entry Operators: Provision of 100 eligible Data Entry Operator in each regional Lab.
- Lab/Operations Manager: 01 (Overall in-charge of the lab).
- **Technical Support:** IT support staff for hardware/network maintenance.
- Quality Assurance Supervisors: To monitor accuracy and throughput.

5. Deliverables

- 1. **Operational Labs:** Fully furnished and equipped labs in Lahore operational within 2 weeks of contract signing.
- 2. **Data Entry:** Data Entry of 100% assigned mutation records in the revenue record.
- 3. **Digital Database:** Cleaned and entered database of mutation records integrated with the Client's system.
- 4. **Reports:** Daily, Weekly, and Monthly progress reports on scanning and entry counts. Monthly attendance time sheet for each operator (along with monthly payment invoice).

6. Payment Schedule (Indicative)

- Establishment of Labs & Hiring of HR: 20% Upon the establishment of Lab in Lahore.
- **Progressive Payments:** Remaining 75% Payment will be made on the monthly basis for the deployed data entry operators (As per actual).
- **Retention Money:** 5% will be retained for the defect liability period (06 months).

- o **Urdu Typing:** Proficiency in Urdu typing (InPage or Unicode) is highly desirable, given that Mutation records (*Parat Sarkar*) are typically in Urdu.
- o Computer Literacy: Basic proficiency in using Windows OS and data entry

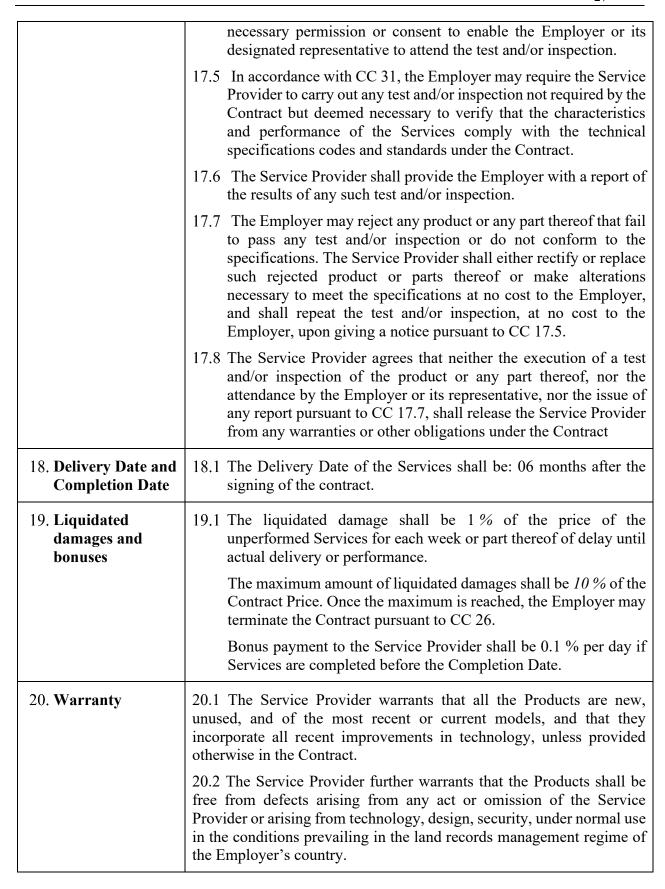
- 1.1 The following words and expressions shall have the meanings hereby assigned to them:

 - (d) "Contract Documents" means the documents listed in the Contract Agreement, including any amendments thereto.

Attachment A to the Conditions of Contract Fraud and Corruption

(Text in this Appendix shall not be modified)

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and Service Providers; any sub-contractors, sub-consultants, service providers or Service Providers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

- a. Defines, for the purposes of this provision, the terms set forth below as follows:
 - i. "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
 - ii. "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii. "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
 - iv. "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - v. "obstructive practice" is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.

- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, Service Providers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring misprocurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner; (ii) to be a nominated sub-contractor, consultant, manufacturer or Service Provider, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;
- e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and Service Providers, and their sub-contractors, sub-consultants, service providers, Service Providers, agents personnel, permit the Bank to inspect³ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated subcontractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its pre-qualification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
