Request for Quotation (RFQ)

- 1. This RFQ is for the Procurement of **Hiring of firm for 3D Mapping of Lahore District** under Punjab Urban Land Systems Enhancement (PULSE).
- 2. The Islamic Republic of Pakistan has received financing from the World Bank (the Bank) toward the cost of the Punjab Urban Land Systems Enhancement (PULSE) project and intends to apply part of the proceeds toward payments under the contract for **Procurement of Hiring of firm for 3D Mapping of Lahore District.**
- 3. Project Management Unit, Board of Revenue (BOR), Govt. of Punjab now invites quotations from Service Providers for the Services described in Annex 1: Employer's Requirements, attached to this RFQ.

Fraud and Corruption

- 4. The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in the attachment to the Contract Conditions (Attachment A).
- 5. In further pursuance of this policy, Service Providers shall permit and shall cause their agents (where declared or not), subcontractors, subconsultants, service providers, suppliers, and personnel, to permit the Bank to inspect all accounts, records and other documents relating to the RFQ and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

Eligible Services

6. All the Services to be supplied under the Contract and financed by the Bank may have their origin in any country in accordance with Para. 10.

Eligible Service Providers

7. In case the Service Provider is a joint venture (JV), all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate a representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Request for Quotations process and, in the event the JV is awarded the Contract, during contract execution.

- 8. A Service Provider may have the nationality of any country, subject to the restrictions pursuant to para. 9 and 10 hereinafter. A Service Provider shall be deemed to have the nationality of a country if the Service Provider is constituted, incorporated or registered in, and operates in conformity with, the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the determination of the nationality of proposed subcontractors or subconsultants for any part of the Contract.
- 9. Firms and individuals may be ineligible if so indicated in para. 10 below and:
 - (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of Goods or the contracting of Works or Services required; or
 - (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of Goods or contracting of Works or Services from that country, or any payments to any country, person, or entity in that country.
- 10. In reference to paras. 6 and 8, for the information of Service Providers, at the present time firms, goods and services from the following countries are excluded from this procurement process:
 - (a) Under para. 6 and 9 (a): none
 - (b) Under para. 6 and 9 (b): none
- 11. A Service Provider that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines, in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework as described in the attachment to the Contract Conditions (Attachment A) paragraph 2.2 d., shall be ineligible to submit Quotations or be awarded or otherwise benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined. A list of debarred firms and individuals is available on the Bank's external website: http://www.worldbank.org/debarr.
- 12. Service Providers that are state-owned enterprises or institutions in the Employer's country may be eligible to compete and be awarded a Contract(s) only if they can establish, in a manner acceptable to the Bank, that they:
 - (a) are legally and financially autonomous;
 - (b) operate under commercial law; and
 - (c) are not under supervision of the Employer.
- 13. A Service Provider shall not have a conflict of interest. Any Service Provider found to have a conflict of interest shall be disqualified. A Service Provider may be considered to have a conflict of interest for the purpose of this Request for Quotations process, if the Service Provider:

- (a) directly or indirectly controls, is controlled by or is under common control with another Service Provider that submitted a Quotation; or
- (b) receives or has received any direct or indirect subsidy from another Service Provider that submitted a Quotation; or
- (c) has the same legal representative as another Service Provider that submitted a Quotation;
- (d) has a relationship with another Service Provider that submitted a Quotation, directly or through common third parties, that puts it in a position to influence the Quotation of another Service Provider, or influence the decisions of the Employer regarding this Request for Quotations process; or
- (e) or any of its affiliates participated as a consultant in the preparation of the scope the Services, that are the subject of the Request for Quotations process; or
- (f) or any of its affiliates has been hired (or is proposed to be hired) by the Employer or Borrower for implementing the Contract; or
- (g) would be providing Goods, works, or non-consulting services resulting from, or directly related to consulting services for the preparation or implementation of the project specified in this Request for Quotations, that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm; or
- (h) has a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who:
 (i) are directly or indirectly involved in the preparation of the Request for Quotations or specifications and/or the evaluation of Quotations, of the subject Contract; or (ii) would be involved in the implementation or supervision of such Contract unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the Request for Quotations process and execution of the Contract.

Performance Security

14. The successful Service Provider shall submit a Performance Security in accordance with the Contract Conditions.

Validity of offers

15. The offers shall be valid for 60 days from the date of submission of quotation.

Quoted Price

- 16. Prices shall be quoted in the following manner:
 - (i) the price of the Services quoted shall include sales tax and all other applicable taxes already paid or payable on the Services if the Contract is awarded to the Service Provider; and
 - *(ii)* the price for inland transportation, insurance, and other local services required to convey the Service Personnel to their final destination (Project Site).
- 17. The Service Provider must quote all the prices in Pak Rupees.

Clarifications

The Employer will forward copies of its response to all Service Providers including a description of the inquirybut without identifying its source.

Opening of Quotations

22. Quotations will be opened by the Employer's representatives immediately after the deadline for the submission of Quotations.

Evaluation of Quotations

- 23. Quotations will be evaluated to ensure compliance with the Scope of Services, Delivery and Completion Schedules and any other requirements of the RFQ.
- 24. Evaluation of the quotation will include an assessment of the Service Provider's technical capacity to mobilize key equipment and personnel for the contract consistent with its quotation regarding availability of manpower/resources in sufficient detail and fully in accordance with the requirements stipulated in Annex-A, Employer's Requirements.
- 25. The comparison shall be on the basis of final prices (inclusive of all the applicable taxes) plus cost of inland transportation and insurance to place of destination, for Services provided from within the Borrower's country; together with prices for any required installation of equipment, training, commissioning and other services. The evaluation of prices shall not take into account custom duties and other taxes levied on imported goods/services quoted CIP and sales and similar taxes levied in connection with the sale or delivery of goods/services.
- 26. The lowest evaluated price will be determined after correcting any arithmetic errors and other specified adjustments, if any.
- 28. Quotation will be evaluated for the whole package under this RFQ. If a Price Schedule shows items listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the Price Schedule shall be assumed not included in the Quotation, and provided that the Quotation is substantially responsive, the average of the item price as quoted by substantially responsive Service Providers will be added to the Quoted Price and the equivalent total price of the Quotation so determined will be used for price comparison.

29. For evaluation and comparison purposes, the currency of the Quotations shall be a single currency, Pak Rupees.

Contract Award

- 30. The Contract will be awarded to the Service Provider/s who meets the following criteria:
 - a. is eligible and offers eligible Services;
 - b. offers the lowest evaluated price/s;
 - c. technically compliant quotation;
 - d. guarantees delivery, in accordance with the delivery period/s;
 - e. is registered with FBR as an active taxpayer for the **last five (05) years** and at the time of bid submission, provides the following documents:
 - i. verifiable and valid active GST and NTN certificates.
 - f. provides copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the quotation to commit the service provider;
 - g. Provides information regarding any litigation, current or during the **last five (05) years,** in which the service provider is involved, the parties concerned, and disputed amount.
 - h. Affidavit regarding non-involvement in any arbitration/ litigation with any government agency / department/Autonomous body/private sector/ organization and not blacklisted anywhere in Pakistan (only for local bidders) on a 200 Rs stamp paper must be attached.

An unsuccessful service provider may request clarifications as to why its quotation was not determined to be successful. The Employer will address this request within a reasonable time.
- 33. The Employer shall publish a contract award notice on its website with free access, if available, or in a newspaper of national circulation or UNDB online, within 15 days after award of contract. The information shall include the name of the successful Service Provider/s, the Contract Price, the Contract duration, summary of its scope and the names of the Service Provider/s and their quoted and evaluated prices.

1.1 Description of Services

1. Background of the Project

The objective is to improve accessibility and understanding of complex landscapes for various stakeholders. The primary purpose of oblique mapping is to provide a more realistic and visually engaging perspective of geographic areas, enhancing the understanding of spatial relationships and features.

This method helps in urban planning, surveying, disaster management, infrastructure development and environmental monitoring by allowing users to visualize landscapes in three dimensions, making data interpretation more intuitive.

2. Objectives

The primary objectives of the oblique mapping project are:

- **To capture high-resolution aerial imagery** with a 5-lens camera system, covering the specified area from both nadir and oblique angles.
- To create a 3D geospatial model of the area, including buildings, infrastructure, and topography, for enhanced visualization and analysis.
- **To deliver accurate 2D orthomosaics** and **3D models** for use by government agencies and stakeholders involved in urban planning, infrastructure, and public safety.

3. Scope of Work

The contractor will be responsible for the following tasks:

3.1 Data Collection

- Aerial Survey: Capture high-resolution imagery of the AOI using a 5-lens camera system. Ensure complete coverage from multiple oblique angles (typically 4 oblique angles and 1 nadir).
- Flight Planning: Develop flight paths that optimize coverage, taking into account weather conditions, airspace regulations, and local restrictions.
- **Georeferencing**: All images must be accurately georeferenced using Global Navigation Satellite System (GNSS) and inertial measurement unit (IMU) data based on the PULSE Geodetic reference.
- Ground Control Points (GCPs): Establish and utilize GCPs to ensure accuracy in mapping and 3D modeling (Based on PULSE Geodetic Control).

3.2 Data Processing

- **Image Preprocessing**: Perform radiometric and geometric corrections on the captured images to ensure consistency and accuracy.
- **Orthorectification**: Produce 2D orthomosaic maps from the nadir imagery, ensuring all images are stitched together with accurate geospatial alignment.
- **3D Model Generation**: Use the oblique imagery to create a high-resolution 3D model of the AOI, including terrain features and building footprints.
- **Digital Elevation Model (DEM)** and **Digital Surface Model (DSM)**: Generate DEMs and DSMs to depict the terrain and surface structures.
- **Point Cloud**: Generate a dense point cloud from the imagery for further 3D analysis and visualization.

3.3 Data Delivery

- Deliverables should include:
 - High-resolution oblique images in a specified format (e.g., JPEG, TIFF) with georeferencing metadata.
 - **2D orthomosaic maps** with a minimum resolution of 5 cm per pixel, provided in formats such as GeoTIFF and other compatible formats.
 - **3D models** in formats such as STL, OBJ, FBX, TLS or compatible GIS software formats (e.g., LAS, LASD/LAZ for point clouds).
 - Photorealistic Model on building footprints by combining LiDAR data with imagery
 - Full documentation of the data collection and processing methodology.
 - 3 days (Theoretical & Practical) Training of PULSE GIS staff will be conducted on complete procedure of Oblique mapping and Data processing including all tools & techniques used
 - Drone Flight Planning & Image Capturing
 - 3D Point Data Collection
 - Data Processing (2D & 3D)
 - Metadata/Descriptive information about the LiDAR data collection, including date, time, sensor type, processing methods, accuracy specifications, and geographic extents.

4. Technical Specifications

4.1 Camera System

- The system should be a 5-lens camera capable of capturing high-resolution imagery from multiple angles:
 - One **nadir camera** (vertical) with a minimum resolution of 120 megapixels.
 - \circ Four **oblique cameras** (Between $\pm 15^{\circ}$ to $\pm 45^{\circ}$) with a minimum resolution of 48 megapixels each.
- The system must support real-time georeferencing using GNSS and IMU integration.
- The resolution of the nadir images must not be >5cm/pixel.
- The resolution of the oblique images must be <10cm/pixel.

4.3 Accuracy Requirements

- Horizontal accuracy: +/- 10 cm.
- Vertical accuracy: +/- 20 cm.
- Ensure that the final 3D model adheres to the accuracy requirements based on GCPs or other control measures.
- High-density: >20 points/m²
- PULSE Geodetic control will be used as reference for marking of GCPs
- All infrastructure including buildings, roads, Green spaces and vegetation must be covered within AOI
- Flight must be below altitude of 300 meters, Flight plan logfile must to be provided

4.4 Geographic Coverage

- KML file of AOI (Walled City Lahore etc.) will be provided to the service provider
- Point Classification by assigning each LiDAR point to a specific category (e.g., ground, vegetation, building) based on Standard LIDAR classification codes:
 - 1: Unclassified
 - 2: Ground
 - 3: Low Vegetation
 - 4: Medium Vegetation
 - 5: High Vegetation
 - 6: Building
 - 9: Water
 - 10: Overlap Points

5. Quality Control and Assurance

• The contractor must provide a report detailing the steps taken during quality control, including image quality assessment, GCP accuracy, and model validation.

6. Deliverables and Timelines

- Provide a detailed schedule for the completion of the following deliverables:
 - 1. Flight plan submission: Within 1 week of contract award
 - 2. Data collection: To be completed within 4 weeks
 - 3. Data processing: Within 3 weeks after data collection.
 - 4. **Final data delivery**: within 2 weeks after data processing. Final deliverables (Ortho-mosaic Imagery, 3D models) must be submitted

7. Compliance with Legal and Regulatory Requirements

- The contractor must comply with all relevant local laws and regulations governing aerial surveys, including obtaining necessary permissions from aviation authorities.
- Data collection must adhere to privacy laws and avoid capturing sensitive areas, unless authorized.

8. Data Security and Confidentiality

- The contractor must ensure that all data is handled securely and confidentially.
- Data transmission and storage must follow industry best practices for cybersecurity and data protection.
- No data may be shared with third parties without prior written consent from the contracting authority.

Attachment A to the Conditions of Contract

Fraud and Corruption

(Text in this Appendix shall not be modified)

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and Service Providers; any sub-contractors, sub-consultants, service providers or Service Providers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

- a. Defines, for the purposes of this provision, the terms set forth below as follows:
 - i. "corrupt practice" is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;
 - ii. "fraudulent practice" is any act or omission, including misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain financial or other benefit or to avoid an obligation;
 - iii. "collusive practice" is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;
 - iv. "coercive practice" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
 - v. "obstructive practice" is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.

- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, Service Providers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring misprocurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti- Corruption Guidelines and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner;¹ (ii) to be a nominated² sub-contractor, consultant, manufacturer or Service Provider, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;
- e. Requires that a clause be included in bidding/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and Service Providers, and their sub-contractors, sub-consultants, service providers, Service Providers, agents personnel, permit the Bank to inspect³ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them auditedby auditors appointed by the Bank.

¹ For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated sub- contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

² A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder inits prequalification application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

³ Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. Such activity includes but is not limited to: accessing and examining a firm's or individual's financial records and information, and making copies thereof as relevant; accessing and examining any other documents, data and information (whether in hard copy or electronic format) deemed relevant for the investigation/audit, and making copies thereof as relevant; interviewing staff and other relevant individuals; performing physical inspections and site visits; and obtaining third party verification of information.
